Flair Airlines can stay in the sky after regulator finds company 'is Canadian'

DECISIONS

- **Grievance, onboard crew rest - *Air Canada v. Canadian Union of Public Employees, Air Canada Component*, 2022 CanLII 44761 (CA LA)**

Union grieves that on flights over 7 hours, the absence on TAP A330s of any place in which cabin personnel can exercise their right to sleep violates the collective agreement – company disputes existence of an unequivocal right to sleep – no violation found – permission to sleep only in accordance with company policy – grievance dismissed
